## The Rescue Train's Feral Fix LA Terms of Agreement

To receive assistance from The Rescue Train's Feral Fix LA you must agree to the following:

## DNR AND OWNERSHIP CLARIFICATION STATEMENT

The Rescue Train is committed to providing care that considers the quality as well as the quantity of an animal's life. For animals experiencing advanced disease, advanced age, multiple disease processes, or a disease considered to be terminal, and unknown medical issues, congenital issues, and/or injuries with regards to community cats it's appropriate to decide in advance whether aggressive measures of resuscitation (CPR) will be employed if needed. DNR means "do not resuscitate". This is a decision that resuscitation (CPR) is not to be performed in the event that the animal stops breathing, has no heartbeat, collapses or becomes unconscious.

Resuscitation (CPR) of a collapsed or unconscious animal is tailored to meet the needs of the individual but may include any or all of the following: Establishing an airway via insertion of an endotracheal tube and administration of oxygen or medications through the tube, Establishing intravenous access via insertion of an intravenous catheter and administration of fluids and injectable medications through the catheter, Chest compressions, and Intracardiac delivery of injectable medications.

Animals that have survived cardiopulmonary arrest and have been successfully resuscitated (CPR) are extremely critical and unstable. Management of the post-arrest patient requires vigilant monitoring and the technical expertise of dedicated critical care personnel. This care is costly and the outcome is uncertain.

I have read and understood the information above or have had it explained to my satisfaction. I understand that the anesthetic, surgical or therapeutic procedures and treatments the animal I have brought for services provided by The Rescue Train, their agents, partners, volunteers, veterinary professionals, contracted veterinarians, contracted veterinary medical providers and/or assigns is undergoing today may involve the risk of complications, injury or even death, from both known and unknown causes and no warranty or guarantee has either been expressed or implied as to the result or cure. Hereby, I expressly agree to release The Rescue Train, and its agents and representatives, from liability for any and all damages to my the animal and agree to hold The Rescue Train, its agents and representatives harmless from any liability associated with the procedure and treatments being performed on the animal.

I further understand The Rescue Train their agents, partners, volunteers, veterinary professionals, contracted veterinarians, contracted veterinary medical providers and/or assigns agree that no resuscitation (CPR) or other aggressive measure will be taken in the event that the animal stops breathing, has no heartbeat, collapses or becomes unconscious.

I further agree and understand the animal I have trapped using a humane trap, has no known owner. This cat is a community cat, feral cat, free-roaming cat and/or any other terminology used to describe a cat living in the community that is not owned by any known person.
